



Minutes of the Public Hearing & Annual Meeting of The Housing Authority of Thurston County February 27, 2020

The regular meeting of the Housing Authority of Thurston County Board of Commissioners held on Thursday, February 27, 2020 at 1206 12th Avenue SE, Olympia, WA 98501. There being a quorum, the meeting was called to order by Chair, Neil McClanahan.

Public Hearing: Chair, Neil McClanahan opened the Public Hearing. Karen spoke about the annual plan update for 2020-2021. There are no significant changes. CFR says in order to qualify for the program, households must be at or below 50% of median income. After that the HA can set preferences. As long as you meet a priority and are at or below 50% income, you can qualify for the program. Public comments are due by March 13th. We will meet at April 16th to approve the annual plan. There were no public comments. Chair, Neil McClanahan closed the Public Hearing.

Agenda Item Discussion: Karen McVea gave an update on the waiting list. We originally were going to pull 800 for the HCV, but we pulled 1,500 onto the active HCV waiting list. We've received the data from the software company. We will begin working on notifying applicants soon. Discussion followed.

Agenda Item Discussion: Bob spoke about the website design. We recently signed a proposal to create a new website. We selected an agency that created the website for the Seattle HA. We are looking at possibly 2 months for our new website. Discussion followed.

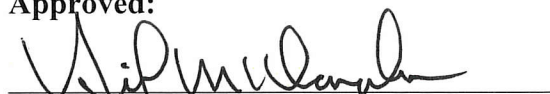
