<u>Public Testimony:</u> Cary Retlin shared the HOME fund is scheduled to post the 2021 RFP on the City of Olympia's website next week. Deadline for questions is 2/12/2021 and responses due 2/26/2021. They will select the finalist by 3/8/2021.

According to the AGO, Housing Authorities can implement rent increases if the burden does not fall on the tenant. HATC decided we would approve rent increases that are below the payment standard to which the HA would absorb the increase.
- We are continuing to pull from the waiting list and it is a little slow due to low vacancies.
- A public attendee, Shawna Lee Mitchell, asked a question regarding her waiting list status and her situation. Karen gave Shawna her phone number to call so that they can discuss her situation.
